

## Ten Year Limited Written Warranty

Lexan\* XL102UV sheet will not break due to loss of impact strength through weathering and will not display excessive yellowing and loss of light transmission as defined herein, within ten (10) years of the date of sale by SABIC Innovative Plastics.

### This limited written warranty is subject to the following conditions:

- 1) This limited written warranty applies exclusively to Lexan XL102UV sheet sold by SABIC Innovative Plastics with a nominal gauge of 0.090" ~.250" in a clear color (112), used, handled, installed, stored, fabricated, installed and maintained according to SABIC Innovative Plastics' recommendations contained in the product Technical Manual.
- 2) This limited written warranty does not apply to sheets that have been scratched, abraded or exposed to corrosive materials or chemicals.
- 3) This limited written warranty is given only to the original purchaser of SABIC Innovative Plastics sheet and does not extend to any subsequent purchaser or transferee. Any warranty claim hereunder must be made immediately within the warranty period by specifying the claim in writing and submitting to SABIC Innovative Plastics the original sales receipt which must contain the name and address of the purchaser, the date of purchase, the complete product name, the lot number and the volume purchased. On request of SABIC Innovative Plastics claimant must allow the material to be inspected on site and/or return the sheet to SABIC Innovative Plastics for testing.
- 4) For the purpose of this limited written warranty:
  - Breakage: If the Lexan XL102UV sheet breaks within 10 years from date of purchase due to a manufacturing defect and subject to the conditions set forth herein, then the purchaser or fabricator designated by the purchaser, will receive free flat replacement Lexan XL102UV sheet, provided the failed sheet, original sales receipt and this warranty are returned to SABIC Innovative Plastics or Authorized Distributor. If a replacement sheet cannot be provided with 14 days SABIC Innovative Plastics may opt to refund the original purchase price.
  - Yellowing will be determined by subjecting a cleaned sheet sample to Yellowness Index Test ASTM D1925 (1977). Any claims for sheet displaying a change in Yellowness Index of 5 units in 5 years or 10 units in 10 years or less compared with the original value, will not be accepted.
  - Loss of light transmission will be determined by subjecting a cleaned sheet sample to Light Transmission Test ASTM D1003 (1977). Any claims for sheet displaying a change of 5% in 5 years or 10% LT units in 10 years, compared to the original value will not be accepted.
- 5) This warranty does not cover (re)-installations or fabrication expenses or any other direct loss(es) which may result from the sheet failure.
- 6) SABIC Innovative Plastics reserves the right to investigate independently the cause of any failure.
- 7) If a claim under this limited written warranty is justified, SABIC Innovative Plastics will provide the purchaser with replacement material free of charge in accordance with the following schedule:

Up to 5 years	100%
in 6 <sup>th</sup> year	75%
in 7 <sup>th</sup> year	60%
in 8 <sup>th</sup> year	45%
in 9 <sup>th</sup> year	30%
in 10 <sup>th</sup> year	15%
- 8) This limited written warranty excludes any consequential / collateral damage due to sheet breakage. This limited written warranty shall be SABIC Innovative Plastics' sole liability and customer's exclusive remedy for the products and all other claims for damages are excluded. The limited written warranty is in lieu of all other warranties (except of title), written or oral, statutory, express or implied, including any warranty of merchantability or fitness of purpose. This ten year limited written warranty shall be governed by the laws of the United States.
- 9) Under no circumstance shall SABIC Innovative Plastics be liable for any amount greater than the original price purchased paid for the Lexan XL102UV sheet.
- 10) This warranty has been issued on March 1st, 2005, is restricted to material sold by SABIC Innovative Plastics after such date and supersedes all previously issued warranties for the products mentioned above.
